#### Agenda 1: Discussion on Academic Audit report

IQAC Coordinator presented the report of Academic audit for all departments. It was discussed to conduct Academic audit two weeks' after the declaration of results.

#### Agenda 2: Discussion on conducting seminars/ FDPs/ Workshops

It was discussed that frequency of conducting seminars, FDPs, and Workshops should be increased for providing better exposure to students and also to fulfill curriculum gaps and for CO-PO attainment.

Agenda 3: Discussion on practical difficulty in identifying weak and bright students HODs shared that identifying weak and bright students merely on the basis of continuous evaluation is difficult. It was proposed to consider class tests and previous results in this activity.

Agenda 4: Presentation on the report of CO-PO mapping of courses as per 2017-18 syllabus pattern HODs presented the summary report of CO-PO mapping of all courses as per 2017-18 academic year. Discussion was also held on Program Outcomes based on technical skills (from PO1 -PO5). IQAC suggested using proper rubrics for CO attainment based on continuous evaluation. It was decided that all feasible evaluation tools should be used to attain CO-PO targets.
